

**Advanced Micro Devices
Fusion11 Taipei Technical Forum and Exhibition Promotion
Official Rules**

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The Advanced Micro Devices Fusion11 Taipei Technical Forum and Exhibition Promotion (the "Promotion") is open only to invitees to the Fusion11 Taipei Technical Forum and Exhibition (the "Event"). Employees of Advanced Micro Devices, Inc., any vendor or exhibitor who is sponsoring any part of the Event, their respective affiliate companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible to participate. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. Winning the prize is contingent upon fulfilling all requirements set forth herein.

2. Sponsor: AMD Far East Ltd., Taiwan Branch 6F, 3, YuanCyu St (NanKang Software Park), Taipei, Taiwan R.O.C.

3. Timing: There are two parts to the Promotion: the "Early Bird Lucky Draw" and the "Event Lucky Draw." The drawings for both Lucky Draws will take place at the Event, which will be held in Taipei, Taiwan, on October 5, 2011, from 9 a.m. to 4 p.m. local time.

4. How to Enter:

All invitees to the Event will be eligible to participate in either (or both) Lucky Draws so long as they register for the Event **AND** are present during the drawings. Registration may involve a short survey on AMD products/services. All information requested during the registration process must be given for a registration to be valid.

A. The Early Bird Lucky Draw

To enter the Early Bird Lucky Draw, you must register for the Event on or before September 19, 2011. Any registrations received after that date will not be eligible for the Early Bird Lucky Draw prize.

B. The Event Lucky Draw

General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other Promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

9. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the

equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Promotion, provided that if it is not possible to award another entry due to discontinuance of the Promotion, or any part of it, for any reason, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein.
